Budget Deliberation Notes:

Councillor Moggy expressed that he would have preferred to see only a 1% increase. The remainder of Council agreed with the 2% increase if the streetlight project was included as this will yield significant savings in only two years. Councillor Fields indicated that this increase made good business sense, all of Council agreed.

Councillors Fields and Reid indicated that the repair of Spragge Street should be included in the capital budget as the condition of the road is very bad and it is a high traffic area. Discussion ensued on whether or not the Red Lodge Road apportionment could be used for Spragge Street as opposed to being put into a reserve as that project likely will not be completed this year. It was decided to change "Red Lodge Road" to "Spragge Street" on the attached capital budget spreadsheet and keep the same dollar figure. After the repairs of Spragge Street, the difference between actual and budgeted will be put into the Red Lodge Road Reserve.
