The cost to remove and replace this portion of the sidewalk will be \$2,200.00. Council agreed this is a safety concern that should be addressed. The CAO informed Council that the Manitoulin Tourism Association's funding for the two students working at the Assiginack Information Booth would expire two weeks early. He suggested to Council that the Township pay the student's wages for the last two weeks of the summer. Council agreed.
