# CORPORATION OF THE TOWNSHIP OF ASSIGINACK

### BY-LAW # 2023-15

Being a By-Law to establish and execute an agreement between adjoining municipalities as to the maintenance and repair of Red Lodge Road.

WHEREAS under the authority of Sections 28 and 29 of the Municipal Act, S.O. 2001, Chapter 25 as amended, for the maintenance and repair of a highway forming a boundary between the said municipalities and that portion of highway used in lieu of the boundary and including the bridges thereon, that is their duty to maintain and repair.

AND WHEREAS Red Lodge Road, being a boundary road between the Township of Assiginack and the Town of Northeastern Manitoulin and the Islands exists, as set out in "Schedule A":

AND WHEREAS pursuant to the said section, the Corporations of the Township of Assiginack and the Town of Northeastern Manitoulin and the Islands respectively deem it necessary to enter into such agreement for the maintenance and repair of Red Lodge Road;

**NOW THEREFORE** THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF ASSIGNACK HEREBY ENACTS AS FOLLOWS:


- 1. That this agreement pertains to Red Lodge Road, as identified in the map provided in "Schedule A".
- That both the Township of Assiginack and the Town of Northeastern Manitoulin
  and the Islands agree to provide routine maintenance and repair to Red Lodge
  Road on a year-round, rotating basis for three (3) years, with automatic renewal,
  until such time that this agreement is terminated in writing by either party.
- 3. That the terms of this agreement, which are attached in Schedule "B," shall form part of this by-law.
- 4. That a copy of this said agreement and a copy of the by-law shall be provided to the Town of Northeastern Manitoulin and the Islands.
- 5. This agreement will be reviewed on an annual basis by Council.
